1.7 AWARD PROCESS

The District shall be the sole judge in making this determination and it shall be done if it is determined to be in Center ISD's best interest. The Respondent further acknowledges that funds may not be specifically appropriated for the Contract and continual ability to make payments under the Contract is contingent upon the funding levels appropriated for each particular appropriation period. The District will use all reasonable efforts to ensure that such funds are available. The Respondent agrees that if future levels of funding for Center ISD are not sufficient to continue operations without any operational reductions, Center ISD, in its discretion, may terminate the Contract or a pending order under the Contract, either in whole or in part. In the event of such termination, Center ISD will not be considered to be in default or breach under the Contract, nor shall it be liable for any further payments ordinarily due under the Contract, nor shall it be liable for any damages or any other amounts which are caused by or associated with such termination. Center ISD shall make best efforts to provide reasonable written advance notice to the Respondent of any such Contract or order termination. Contractor acknowledges and agrees that payments for services provided under this Contract are contingent upon Center ISD receipt of funds appropriated by the Texas Legislature.
- 10. **Guarantee** A minimum of ninety (90) days guarantee or standard commercial warranty, whichever is greater, shall be provided on all materials. In the event of failure, the vendor agrees to repair or replace such units at no cost to Center ISD, within ten (10) working days.
- 11. **Term and Termination** This Contract shall become effective on the date signed by the appropriate official of Center ISD. Notwithstanding the termination or expiration of this Contract, the provisions of this Contract regarding confidentiality, indemnification, transition, records, right to audit and independent audit, property rights, dispute resolution, invoice and fees verification, and default shall survive the termination or expiration dates of this Contract. Center ISD may, in its sole discretion, terminate this Contract upon thirty (30) days' written notice to Contractor. Such notice may be provided by facsimile or certified mail return receipt requested and is effective upon Contractor's receipt. In the event of such termination, the Respondent shall, unless otherwise mutually agreed upon in writing, cease all work immediately upon the effective date of termination. The District and/or other Customers shall be liable only for payments for any goods or services ordered from the Respondent before the termination date.
- 12. **Rights to Invention** If the Federal award meets the definition of "funding agreement" under 37 CFR § 401.2 (a) and the recipient or subrecipient wishes to enter into a contract with a small business firm or nonprofit organization regarding the substitution of parties, assignment or performance of experimental, developmental, or research work under that "funding agreement," the recipient or subrecipient must comply with the requirements of 37 CFR Part 401, "Rights to Inventions Made by Nonprofit Organizations and Small Business Firms Under Government Grants, Contracts and Cooperative Agreements," and any implementing regulations issued by the awarding agency.
- 13. Clean Air Act (42 U.S.C. 7401–7671q.) and the Federal Water Pollution Control Act (33 U.S.C. 1251–1387), as amended—Contracts and subgrants of amounts in excess of \$150,000 must contain a provision that requires the non-Federal award to agree to comply with all applicable standards, orders or regulations issued pursuant to the Clean Air Act (42 U.S.C. 7401–7671q) and the Federal Water Pollution Control Act as amended (33 U.S.C. 1251–1387). Violations must be reported to the Federal awarding agency and the Regional Office of the Environmental Protection Agency (EPA).
- 14. **Energy Policy and Conservation Act** Respondent certifies it is in compliance with mandatory standards and policies relating to energy efficiency which are contained in the state energy conservation plan issued in compliance with the Energy Policy and Conservation Act (Pub. L. 94-163, 89 Stat. 871).

- 18. **Termination for Convenience** Pursuant to 48 CFR 52.249.2 when federal funds are expended by Center ISD reserves the right to immediately terminate any Agreement in excess of \$10,000 in the event of a breach or default of the Agreement by Vendor, in the event vendor fails performance of work under any contract in whole or, from time to time, in part if The District determines that a termination is in Center ISD's best interest. The District may terminate any resulting contract for convenience by providing (1) a statement that the contract is being terminated for the convenience of the district, (2) the effective date of termination, (3) the extent of termination, (4) any special instructions, and (5) the steps the contractor is to take to minimize the impact on personnel. Upon any notification of termination for convenience, the contractor is to (1) stop work immediately on the terminated portion of the contract, (2) terminate all subcontracts related to the terminated portion of the prime contract, (3) advise The District of any special circumstances precluding stoppage of work, (4) perform the continued portion of the contract if the termination is partial, (5) take any action necessary to protect property in the contractor's possession in which The District has an interest, (6) notify The District of any legal proceedings growing out of any subcontract, (7) settle any subcontractor claims arising out of the termination, and (8) dispose of termination inventory as directed by the district. - 19. **Termination for Cause/Default** If Contractor is found to be in default under any provision of this contract, The District may cancel the contract without notice and either re-solicit or award the contract to the next best responsive and responsible Respondent. In the event of abandonment or default, Contractor will be responsible for paying damages to Center ISD including, but not limited to, re-procurement costs, and any consequential damages to The District resulting from contractor's non-performance. The defaulting contractor will not be considered in the re-solicitation and may not be considered in future solicitations for the same type of work unless the specification or scope of work is significantly changed. The District expressly does not waive any rights, remedies, privileges, or immunities available to it as an agency of the State of Texas or otherwise available to it under the referenced contract and under applicable law among other things, The District reserves the right to refer this matter to the Office of the Attorney General of the State of Texas for handling.
- 20. **Termination for Non-Appropriations** The award contract is subject to the appropriation of funds each fiscal year by Center ISD. The District cannot guarantee purchases obligated with federal awards. Pursuant to 2 CFR 200.339-346, the funding

- grant may be suspended or terminated. In the event of a termination, the Respondent will be paid for services rendered and the contract terminated effective upon notice of termination.
- 21. **Conflict of Interest** Dealings with Public Servants Affirmation: Respondent has not given, offered to give, nor intends to give at any time hereafter any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor, or service to a public servant in connection with the submitted response. - 22. **E-Verify Program** Contractor certifies that for contracts for services, Contractor shall utilize the U.S. Department of Homeland Security's E-Verify system during the term of the contract to determine the eligibility of: 1. all persons employed by Contractor to perform duties within Texas; and 2. all persons, including subcontractors, assigned by Contractor to perform work pursuant the contract within the United States of America. If it is determined that Contractor has violated the certifications set forth in this Section, then (1) Contractor shall be in breach of contract, (2) Center ISD shall have the option to terminate the contract for cause without prior notice, and (3) in addition to any other rights or remedies available to Center ISD under the contract, Respondent shall be responsible for all costs incurred by Center ISD to obtain substitute services to replace the terminated contract. - 23. **Survival of Terms** Termination of the Contract for any reason shall not release the Respondent from liability or obligation set forth in the Contract that is expressly stated to survive any such termination or by its nature would be intended to be applicable following any such termination, including the provisions regarding confidentiality, indemnification, transition, records, audit, property rights, dispute resolution, invoice and fees verification.
- 24. **Confidentiality and Public Information** Notwithstanding any provisions of this Contract to the contrary, Contractor understands that Center ISD will comply with the Texas Public Information Act, Government Code, Chapter 552 as interpreted by judicial opinions and opinions of the Attorney General of the State of Texas. Center ISD agrees to notify Contractor in writing within a reasonable time from receipt of a request for information related to Contractor's work under this contract. Contractor will cooperate with Center ISD in the production of documents responsive to the request. Center ISD will make a determination whether to submit a Public Information Act request to the Attorney General. Contractor will notify Center ISD within twenty-four (24) hours of receipt of any third party requests for information that was provided by The District for use in performing the Contract. This Contract and all data and other information generated or otherwise obtained in its performance may be subject to the Texas Public Information Act. Contractor agrees to maintain the confidentiality of information received from Center ISD during the performance of this Contract, including information which discloses confidential personal information particularly, but not limited to, social security numbers.
- 25. Insurance and Other Security Contractor represents and warrants that it will, within five (5) business days of executing this agreement, provide Center ISD with current certificates of insurance and bonding information or other proof acceptable to Center ISD of the following insurance coverage: Standard Workers Compensation Insurance covering all personnel who will provide services under this Contract; Commercial General Liability Insurance, personal injury and advertising injury with, at a minimum, the following limits: \$500,000 minimum each occurrence; \$1,000,000 per general aggregate. Contractor represents and warrants that all of the above coverage is with companies licensed in the state of Texas, with "A" rating from Best, and authorized to provide the corresponding coverage. Contractor also represents and warrants that all policies contain endorsements prohibiting cancellation except upon at least thirty (30) days prior written notice to Center ISD. Contractor represents and warrants that it shall maintain the above insurance coverage during the term of this Contract, and shall provide Center ISD with an executed copy of the policies immediately upon request.
- 26. Indemnification Acts or Omissions Contractor shall indemnify and hold harmless Center ISD, the State of Texas and any Customers, AND/OR THEIR OFFICERS, AGENTS, EMPLOYEES, REPRESENTATIVES, CONTRACTORS, ASSIGNEES, AND/OR DESIGNEES FROM ANY AND ALL LIABILITY, ACTIONS, CLAIMS, DEMANDS, OR SUITS, AND ALL RELATED COSTS, ATTORNEY FEES, AND EXPENSES arising out of, or resulting from any acts or omissions of the Contractor or its agents, employees, subcontractors, Order Fulfillers, or suppliers of subcontractors in the execution or performance of the Contract and any Purchase Orders issued under the Contract. THE DEFENSE SHALL BE COORDINATED BY CONTRACTOR WITH THE LEGAL COUNSEL FOR CENTER ISD WHEN CENTER ISD IS NAMED DEFENDANT IN ANY LAWSUIT AND CONTRACTOR MAY NOT AGREE

TO ANY SETTLEMENT WITHOUT FIRST OBTAINING THE CONCURRENCE FROM CENTER ISD. CONTRACTOR AND The District AGREE TO FURNISH TIMELY WRITTEN NOTICE TO EACH OTHER OF ANY SUCH CLAIM.

27. Infringements

- a. Contractor shall indemnify and hold harmless Center ISD, the State of Texas and any Customers, AND/OR THEIR EMPLOYEES, AGENTS, REPRESENTATIVES, CONTRACTORS, ASSIGNEES, AND/OR DESIGNEES from any and all third party claims involving infringement of United States patents, copyrights, trade and service marks, and any other intellectual or intangible property rights in connection with the PERFORMANCES OR ACTIONS OF CONTRACTOR PURSUANT TO THIS CONTRACT. CONTRACTOR AND The District AGREE TO FURNISH TIMELY WRITTEN NOTICE TO EACH OTHER OF ANY SUCH CLAIM. CONTRACTOR SHALL BE LIABLE TO PAY ALL COSTS OF DEFENSE INCLUDING ATTORNEYS' FEES. THE DEFENSE SHALL BE COORDINATED BY CONTRACTOR WITH LEGAL COUNSEL FOR CENTER ISD WHEN CENTER ISD IS NAMED DEFENDANT IN ANY LAWSUIT AND CONTRACTOR MAY NOT AGREE TO ANY SETTLEMENT WITHOUT FIRST OBTAINING THE CONCURRENCE FROM CENTER ISD.
- b. Contractor shall have no liability under this section if the alleged infringement is caused in whole or in part by:
 - i. use of the product or service for a purpose or in a manner for which the product or service was not designed,
 - ii. any modification made to the product without Contractor's written approval,
 - iii. any modifications made to the product by the Contractor pursuant to Center ISD specific instructions,
 - iv. any intellectual property right owned by or licensed to Center ISD, or
 - v. any use of the product or service by Center ISD that is not in conformity with the terms of any applicable license agreement.
- c. If Contractor becomes aware of an actual or potential claim, or Center ISD provides Contractor with notice of an actual or potential claim, Contractor may (or in the case of an injunction against Center ISD, shall), at Contractor's sole option and expense:
 - i. procure for The District the right to continue to use the affected portion of the product or service, or
 - ii. modify or replace the affected portion of the product or service with functionally equivalent or superior product or service so that Center ISD's use is non-infringing.

28. Taxes/Workers' Compensation/Unemployment Insurance - Including Indemnity

- a. CONTRACTOR AGREES AND ACKNOWLEDGES THAT DURING THE EXISTENCE OF THIS CONTRACT, CONTRACTOR SHALL BE ENTIRELY RESPONSIBLE FOR THE LIABILITY AND PAYMENT OF CONTRACTOR'S AND CONTRACTOR'S EMPLOYEES' TAXES OF WHATEVER KIND, ARISING OUT OF THE PERFORMANCES IN THIS CONTRACT. CONTRACTOR AGREES TO COMPLY WITH ALL STATE AND FEDERAL LAWS APPLICABLE TO ANY SUCH PERSONS, INCLUDING LAWS REGARDING WAGES, TAXES, INSURANCE, AND WORKERS' COMPENSATION. CENTER ISD, ANY CUSTOMER, AND/OR THE STATE SHALL NOT BE LIABLE TO THE CONTRACTOR, ITS EMPLOYEES, AGENTS, OR OTHERS FOR THE PAYMENT OF TAXES OR THE PROVISION OF UNEMPLOYMENT INSURANCE AND/OR WORKERS' COMPENSATION OR ANY BENEFIT AVAILABLE TO AN CENTER ISD EMPLOYEE OR AN EMPLOYEE OF ANOTHER GOVERNMENTAL ENTITY CUSTOMER.
- b. Contractor agrees to indemnify and hold harmless center isd, and/or their employees, agents, representatives, contractors, and/or assignees from any and all liability, actions, claims, demands, or suits, and all related costs, attorneys' fees, and expenses, relating to tax liability, unemployment insurance and/or workers' compensation in its performance under this contract. Contractor shall be liable to pay all costs of defense including attorneys' fees. The defense shall be coordinated by contractor with the legal counsel for center isd, and contractor may not agree to any settlement without first obtaining the concurrence from center isd. Contractor and the district agree to furnish timely written notice to each other of any such claim.
- 29. **Changes In Law and Compliance with Laws** Any alterations, additions, or deletions to the terms of the contract that are required by changes in federal or state law or regulations are automatically incorporated
- 30. **Taxes** Purchases made by Center ISD are exempt from the State Sales Tax and Federal Excise Tax. Center ISD will furnish Tax Exemption Certificates to Contractor prior to purchase as requested by Contractor. Contractor represents and warrants that it shall pay all taxes or similar amounts resulting from the contract, including, but not limited to, any federal, State, or local income, sales or excise taxes of Contractor or its employees. Center ISD shall not be liable for any taxes resulting from the contract.

- 31. Dispute Resolution The dispute resolution process provided for in Texas Government Code, Chapter 2260 shall be used by Center ISD and Contractor to resolve any dispute arising under the Contract. The dispute resolution process provided for in Chapter 2260 shall be used, as further described herein, to attempt to resolve a claim for breach of contract asserted by the Respondent under the Contract. If the Respondent's claim for breach of Contract cannot be resolved by the Parties in the ordinary course of business, it shall be submitted to the negotiation process provided in Chapter 2260. To initiate the process, the Respondent shall submit written notice, as required by Chapter 2260, to the Deputy Comptroller or his or her designee. The notice shall also be given to the individual identified in the Contract for receipt of notices. Compliance by the Respondent with Chapter 2260 is a condition precedent to the filing of a contested case proceeding under Chapter 2260. The contested case process provided in Chapter 2260 is the Respondent's sole and exclusive process for seeking a remedy for an alleged breach of Contract by The District if the Parties are unable to resolve their disputes as described above. Compliance with the contested case process provided in Chapter 2260 is a condition precedent to seeking consent to sue from the Legislature under Chapter 107, Civil Practices and Remedies Code. Neither the execution of the Contract by The District nor any other conduct of any representative of The District relating to the Contract shall be considered a waiver of sovereign immunity to suit. For all other specific breach of contract claims or disputes under the Contract, The District and the Respondent shall first attempt to resolve them through direct discussions in a spirit of mutual cooperation. If the Parties' attempts to resolve their disagreements through negotiations fail, the dispute will be mediated by a mutually acceptable third party to be chosen by The District and the Respondent within fifteen (15) days after written notice by one them demanding mediation under this Section. The Respondent shall pay all costs of the medication unless The District in its sole good faith discretion, approves its payment of all or part of such costs. By mutual agreement, The District and the Respondent may use a non-binding form of dispute resolution other than mediation. The purpose of this Section is to reasonably ensure that The District and the Respondent shall, in good faith, utilize mediation or another non-binding dispute resolution process before pursuing litigation. The District participation in, or the results of, any mediation or other non-binding dispute resolution process under this Section or the provisions of this Section shall not be construed as a waiver by The District of (1) any rights, privileges, defenses, remedies or immunities available to Center ISD; (2) The District termination rights; or (3) other termination provisions or expiration dates of the Contract. Notwithstanding any other provision of the Contract to the contrary, unless otherwise requested or approved in writing by The District the Respondent shall continue performance and shall not be excused from performance during the period any breach of contract claim or dispute is pending under either of the above processes; however, the Respondent may suspend performance during the pendency of such claim or dispute if the Respondent has complied with all provisions of §2251.051, Gov't Code, and such suspension of performance is expressly applicable and authorized under that law.
- 32. Representations, Warranties, and General Provisions Under Government Code, Section 2155.004 (relating to certain taxes), Contractor represents and warrants that Contractor is not ineligible to receive this Contract and acknowledges that this Contract may be terminated and payment withheld if this representation and warranty is inaccurate. Contractor represents and warrants that it is not delinquent in the payment of any franchise taxes owed the State of Texas. Also, Government Code, Section 2155.004 prohibits a person or entity from receiving a contract if that person or entity received compensation for participating in preparing the solicitation or specifications for the Contract.
- 33. Liability for Taxes Contractor represents and warrants that it shall pay all taxes or similar amounts resulting from this Contract, including, but not limited to, any federal, State, or local income, sales or excise taxes of Contractor or its employees. Center ISD shall not be liable for any taxes resulting from this Contract.
- 34. **Amendments** Except as provided in this Contract, this Contract may be amended only upon written agreement between Center ISD and Contractor; however, any amendment of this Contract that conflicts with the laws of the State of Texas shall be void ab initio.
- 35. **Applicable Law; Venue** This Contract shall be governed by and construed in accordance with the laws of the State of Texas. The venue of any suit arising under this Contract is fixed in any court of competent jurisdiction of Shelby County, Texas.
- 36. **Strict Compliance** Time is of the essence in the performance of this Contract. Contractor shall strictly comply with all of the deadlines, requirements, and Standards of Performance for this Contract.
- 37. **Assignments** Without the prior written consent of Center ISD Contractor may not assign this Contract, in whole or in part, and may not assign any right or duty required under it.

- 38. Partially Completed Work No later than the first calendar day after the termination of this Contract, or at Center ISD request, Contractor shall deliver to Center ISD all completed, or partially completed, work and any and all documentation or other products and results of these services. Failure to timely deliver such work or any and all documentation or other products and results of the services shall be considered a material breach of this Contract. Contractor shall not make or retain any copies of the work or any and all documentation or other products and results of the services without the prior written consent of Center ISD.
- 39. **Federal, State, and Local Requirements** Contractor shall demonstrate on-site compliance with the Federal Tax Reform Act of 1986, Section 1706, amending Section 530 of the Revenue Act of 1978, dealing with issuance of Form W-2's to common law employees. Contractor is responsible for both federal and State unemployment insurance coverage and standard Worker's Compensation Insurance coverage. Contractor shall comply with all federal and State tax laws and withholding requirements. Center ISD shall not be liable to Contractor or its employees for any Unemployment or Workers' Compensation coverage, or federal or State withholding requirements. Contractor shall indemnify Center ISD and shall pay all costs, penalties, or losses resulting from Contractor's omission or breach of this Section.
- 40. **Severability Clause** In the event that any provision of this Contract is later determined to be invalid, void, or unenforceable, then the remaining terms, provisions, covenants, and conditions of this Contract shall remain in full force and effect, and shall in no way be affected, impaired, or invalidated.
- 41. **Applicable Law and Conforming Amendments** Contractor must comply with all laws, regulations, requirements and guidelines applicable to a Contractor providing services to a governmental entity of the state of Texas as these laws, regulations, requirements and guidelines currently exist and as they are amended throughout the term of this Contract. Center ISD reserves the right, in its sole discretion, to unilaterally amend this Contract throughout its term to incorporate any modifications necessary for Center ISD or Contractor's compliance with all applicable State and federal laws, and regulations.
- 42. **No Waiver** Nothing in this Contract shall be construed as a waiver of Center ISD's sovereign immunity. This Contract shall not constitute or be construed as a waiver of any of the privileges, rights, defenses, remedies, or immunities available to Center ISD. The failure to enforce, or any delay in the enforcement, of any privileges, rights, defenses, remedies, or immunities available to the State of Texas under this Contract or under applicable law shall not constitute a waiver of such privileges, rights, defenses, remedies, or immunities or be considered as a basis for estoppel. Center ISD does not waive any privileges, rights, defenses, or immunities available to Center ISD by entering into this Contract or by its conduct prior to or subsequent to entering into this Contract.
- 43. Independent Contractor or Contractor's employees, representatives, agents and any subcontractors shall serve as an independent contractor in providing the services under any PO resulting from this RFP or awarded contract. Contractor or Contractor's employees, representatives, agents and any subcontractors shall not be employees of Center ISD. Should Contractor subcontract any of the services required in this RFP, Contractor expressly understands and acknowledges that in entering into such subcontract(s), Center ISD is in no manner liable to any subcontractor(s) of Contractor. In no event shall this provision relieve Contractor of the responsibility for ensuring that the services rendered under all subcontracts are rendered in compliance with this RFP.
- 44. **Limitation on Authority; No Other Obligations** Contractor shall have no authority to act for or on behalf of Center ISD except as expressly provided for in this Contract; no other authority, power or use is granted or implied. Contractor may not incur any debts, obligations, expenses, or liabilities of any kind on behalf of Center ISD.
- 45. Patent, Trademark, Copyright and Other Infringement Claims Contractor shall indemnify, save and hold harmless Center ISD from and against claims of patent, trademark, copyright, trade secret or other proprietary rights, violations or infringements arising from Center ISD's or Contractor's use of or acquisition of any services or other items provided to The District by Contractor or otherwise to which Center ISD has access as a result of Contractor's performance under this Contract, provided that Center ISD shall notify Contractor of any such claim within a reasonable time of Center ISD's receiving notice of any such claim. If Contractor is notified of any claim subject to this section, Contractor shall notify Center ISD of such claim within five (5) business days of such notice. No settlement of any such claim shall be made by Contractor without Center ISD's prior written approval. Contractor shall reimburse The District for any claims, damages, losses, costs, expenses, judgments or any other amounts, including, but not limited to, attorneys' fees and court costs, arising from any such claim. Contractor shall pay all reasonable costs of Center ISD's counsel and shall also pay costs of multiple counsel, if

- required to avoid conflicts of interest. Contractor represents that it has determined what licenses, patents and permits are required under this Contract and has acquired all such licenses, patents and permits.
- **46. Electrical Items** All electrical items must meet all applicable OSHA standards and regulations, and bear the appropriate listing from Underwriters Laboratory (UL), Factory Mutual Resource Corporation (FMRC), or National Electrical Manufacturers Association (NEMA).
- 47. **Legal and Regulatory Actions** Respondent represents and warrants that it is not aware of and has received no notice of any court or governmental agency actions, proceedings or investigations, etc., pending or threatened against Respondent or any of the individuals or entities included in the Response within the five (5) calendar years immediately preceding the submission of the Response that would or could impair Respondent's performance under the contract, relate to the solicited or similar goods or services, or otherwise be relevant to Center ISD consideration of the Response. If Respondent is unable to make the preceding representation and warranty, then Respondent instead represents and warrants that it has included as a detailed attachment in its Response a complete disclosure of any such court or governmental agency actions, proceedings, or investigations, etc. that would or could impair Respondent's performance under the contract, relate to the solicited or similar goods or services, or otherwise be relevant to Center ISD's consideration of the Response. In addition, Respondent represents and warrants that it shall notify Center ISD in writing within five (5) business days of any changes to the representations or warranties in this clause and understands that failure to so timely update Center ISD shall constitute breach of contract and may result in immediate termination of the contract.
- **48. Change in Law and Compliance with Laws** Any alterations, additions, or deletions to the terms of the contract that are required by changes in federal or state law or regulations are automatically incorporated into the contract without written amendment hereto, and shall become effective on the date designated by such law or by regulation.
- 49. **Damage to Government Property** Respondent shall be liable for all damage to government-owned, leased, or occupied property and equipment caused by the Respondent and its employees, agents, subcontractors, and suppliers, including any delivery or cartage company, in connection with any performance pursuant to the contract. Respondent shall notify The District in writing of any such damage within one (1) calendar day. Respondent is responsible for the removal of all debris resulting from work performed under the contract.
- **50. Deceptive Trade Practices; Unfair Business Practices** Contractor represents and warrants that it has not been the subject of allegations of Deceptive Trade Practices violations under Tex. Bus. & Com. Code, Chapter 17, or allegations of any unfair business practice in any administrative hearing or court suit and that Contractor has not been found to be liable for such practices in such proceedings. Contractor certifies that it has no officers who have served as officers of other entities who have been the subject allegations of Deceptive Trade Practices violations or allegations of any unfair business practices in an administrative hearing or court suit and that such officers have not been found to be liable for such practices in such proceedings
- **51. Equal Opportunity** Contractor represents and warrants that it shall not discriminate against any person on the basis of race, color, national origin, creed, religion, political belief, sex, sexual orientation, age, and disability in the performance of this Contract.
- **52. Antitrust** Contractor represents and warrants that neither Contractor nor any firm, corporation, partnership, or institution represented by Contractor, or anyone acting for such firm, corporation or institution has (1) violated the antitrust laws of the State of Texas under Tex. Bus. & Com. Code, Chapter 15, or the federal antitrust laws; or (2) communicated directly or indirectly the Proposal to any competitor or any other person engaged in such line of business during the procurement process for this Contract.
- **53. Financial Interests; Gifts** Contractor represents and warrants that neither Contractor nor any person or entity that will participate financially in this Contract has received compensation from Center ISD or any agency of the State of Texas for participation in preparation of specifications for this Contract. Contractor represents and warrants that it has not given, offered to give, and does not intend to give at any time hereafter, any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor or service to any public servant or employee in connection with this Contract.
- **54. False Statements; Breach of Representations** By signing this Contract, Contractor makes all the representations, warranties, guarantees, certifications and affirmations included in this Contract. If Contractor signs Proposal or Contract with a false statement or it is subsequently determined that Contractor has violated any of the representations, warranties, guarantees, certifications, or affirmations included in this Contract, Contractor shall be in default under this Contract and Center ISD may

- terminate or void this Contract for cause and pursue other remedies available to Center ISD under this Contract and applicable law.
- **55. Force Majeure** Neither Contractor nor Center ISD shall be liable to the other for any delay in, or failure of performance, of any requirement included in this Contract or any PO resulting from this RFP caused by force majeure. The existence of such causes of delay or failure shall extend the period of performance until after the causes of delay or failure have been removed provided the non-performing party exercises all reasonable due diligence to perform. Force majeure is defined as acts of God, war, fires, explosions, hurricanes, floods, failure of transportation, epidemics and pandemics resulting in an executive branch of state or federal government declaration of an emergency, or other causes that are beyond the reasonable control of either party and that by exercise of due foresight such party could not reasonably have been expected to avoid, and which, by the exercise of all reasonable due diligence, such party is unable to overcome. Each party must inform the other in writing, with proof of receipt, within three (3) business days of the existence of such force majeure, or otherwise waive this right as a defense.
- 56. **Work Made for Hire** For the purposes of this Contract, the term "Work" is defined as all reports, statistical analyses, work papers, work products, materials, approaches, designs, specifications, systems, documentation, methodologies, concepts, research, materials, intellectual property or other property developed, produced, or generated in connection with this Contract. All work performed pursuant to this Contract is made the exclusive property of Center ISD. All right, title and interest in and to said property shall vest in Center ISD upon creation and shall be deemed to be a work for hire and made in the course of the services rendered pursuant to this Contract. To the extent that title to any such work may not, by operation of law, vest in Center ISD, or such work may not be considered a work made for hire, all rights, title and interest therein are hereby irrevocably assigned to Center ISD. *Center ISD* shall have the right to obtain and to hold in its name any and all patents, copyrights, registrations or such other protection as may be appropriate to the subject matter, and any extensions and renewals thereof. Contractor must give The District and/or the State of Texas, as well as any person designated by *Center ISD*, all assistance required to perfect the rights defined herein without any charge or expense beyond those amounts payable to Contractor for the services rendered under this Contract.
- 57. **Default** If Contractor is found to be in default under any provision of this Contract, Center ISD may cancel the Contract without notice and either re-solicit or award the contract to the next best responsive and responsible Respondent. In the event of abandonment or default, Contractor will be responsible for paying damages to Center ISD including but not limited to re-procurement costs, and any consequential damages to the State of Texas or Center ISD resulting from Contractor's non-performance. The defaulting Contractor will not be considered in the re-solicitation and may not be considered in future solicitations for the same type of work, unless the specification or scope of work is significantly changed.
- 58. **Note to Respondent** Any terms and conditions attached to the response will not be considered unless specifically referred to on this Request for Proposal and may result in disqualification of the response.
- 59. **Immigration** The Contractor represents and warrant that it shall comply with the requirements of the Immigration Reform and Control Act of 1986 and 1990 regarding employment verification and retention of verifications forms for any individuals hired on or after November 6, 1986, who will perform any labor or services under the Contract and the Illegal Immigration Reform and Immigrant Responsibility Act of 1996 (IIRIRA) enacted on September 30, 1996.
- 60. **Davis-Bacon Act** as amended (40 U.S.C. 3141-3148). When required by Federal program law, all prime construction contracts in excess of \$2,000 awarded by non-Federal entities must include a provision for compliance with the Davis-Bacon Act (40 U.S.C. 3141-3144, and 3146-3148) as supplemented by Department of Labor regulations (29 CFR Part 5, "Labor Standards Provisions Applicable to Contracts Covering Federally Financed and Assisted Construction"). In accordance with the statute, contractors must be required to pay wages to laborers and mechanics at a rate not less than the prevailing wages specified in a wage determination made by the Secretary of Labor. In addition, contractors must be required to pay wages not less than once a week. - 62. **Drug Free Work Place** Respondent represents and warrants that it shall comply with the applicable provisions of the Drug-Free Work Place Act of 1988 (41 U.S.C. § 701 et seq.) and maintain a drug-free work environment.
- 63. **Federal Occupational Safety and Health Law** Respondent represents and warrants that all articles and services shall meet or exceed the safety standards established and promulgated under the Federal Occupational Safety and Health Act of 1970, as amended (29 U.S.C. Chapter 15). Contractor warrants that the product sold to Center ISD shall conform to the standards promulgated by the U. S. Department of Labor under the Occupational Safety and Health Act. In the event the product does not conform to OSHA standards, Center ISD may return the product for correction or replacement at the Contractor's expense. In the event Contractor fails to make the appropriate correction within a reasonable time (15 working days) correction made by The District will be at the Contractor's expense.
- 64. Substitutions are not permitted without written approval of Center ISD.
- 65. **Public Disclosure** No public disclosures or news releases pertaining to this contract shall be made without prior written approval of Center ISD.
- 66. Contract Work Hours and Safety Standards Act (40 U.S.C. 3701-3708). Where applicable, all contracts awarded by the non-Federal entity in excess of \$100,000 that involve the employment of mechanics or laborers must include a provision for compliance with 40 U.S.C. 3702 and 3704, as supplemented by Department of Labor regulations (29 CFR Part 5). Under 40 U.S.C. 3702 of the Act, each contractor must be required to compute the wages of every mechanic and laborer on the basis of a standard work week of 40 hours. Work in excess of the standard work week is permissible provided that the worker is compensated at a rate of not less than one and a half times the basic rate of pay for all hours worked in excess of 40 hours in the work week. - 69. Testing and Inspection Center ISD may test and inspect goods and services purchased under the Contract to ensure compliance with the specifications of this RFP and the Contract. The District may also test and inspect goods and services before they are purchased under the Contract. Authorized Center ISD personnel shall have access to the Respondent's place of business for the purpose of inspecting the goods. To the extent practical, The District inspections will not disrupt the Respondent's daily operations. Tests shall be performed on samples submitted with the Proposal or on samples taken from regular shipments. All costs of testing and inspection shall be borne by the Respondent. In the event the goods tested fail to meet or exceed all conditions and requirements of the RFP and Contract, the goods will be rejected in whole or in part, at Center ISD's option, and returned to the Respondent or held for disposition at the Respondent's expense. Latent defects may result in cancellation of the Contract at no expense to Center ISD. If material fails to meet specifications, the Respondent will be notified by fax, mail, or e-mail. The Respondent will have ten (10) working days after receipt of the notification to remove the rejected material from Center ISD or any Customer property. Material will be removed at the Respondent's expense. Material not removed in the allotted time period will be disposed by Center ISD. The Respondent will be charged for all disposable expenses conducted by The District or any Customer.

- 72. **Protest** The District procedure for protests can be obtained by contacting the Center ISD. The District may disclose information regarding the protest to TEA or other awarding agency. 2 CFR § 200.318(k). The protestor must comply with the procedures set forth in Center ISD complaint policy EF(LOCAL).
- 73. **Withdrawal of Proposal** Proposals may be withdrawn prior to the specified deadline by providing written notification to Center ISD. All approvals shall be based upon an acceptable written reason for the action.
- **74. Signatories** The undersigned signatories represent and warrant that they have full authority to enter into this Contract on behalf of the respective parties.
- 75. **Merger** This Contract contains the entire agreement between Contractor and *Center ISD* and supersedes any prior understandings or oral or written agreements between Center ISD and Contractor on the matters contained herein. No modification, alteration, or waiver of any term, covenant, or condition of this Contract and any attachments shall be valid unless in writing and executed by Center ISD and Contractor.
- **76. Notices** Any written notices required under this Contract will be by either hand delivery to Contractor's office address specified on Page 1 of this Contract or by U.S. Mail, certified, return receipt requested. - **77.** Notice will be effective on receipt by the affected party. Either party may change the designated notice address in this Section by written notification to the other party.
