3.1 Suicide Prevention/Mental Health Awareness

Ashley Wulf indicated that Kasi Trent-Ashley has submitted them and is awaiting Board approval. Joyce Permenter requested a copy and Melissa Torrence said she would get Kasi Trent-Ashley to send them to her.

3.2 Parenting and Paternity Awareness (P.A.P.A.) Training

Amber Mathews noted that the District sent a teacher to Region 7 to be trained in P.A.P.A on January 31, 2024, but the teacher is no longer employed by the District. Another training is scheduled in November 2024. It was noted that because Center High School offers a health class, this program must be taught. The 80th Legislature passed HB 2176, which mandates a parenting and paternity awareness program to be utilized in the high school health curriculum beginning in the 2008-2009 school year.

3.3 Ross Breast Center

Joyce Permenter reported there were 16 appointments available/scheduled at Center High School and 13 mammograms were performed. There were 15 appointments available/scheduled at Center Middle School and 12 mammograms were performed. There were 15 appointments available, 12 appointments were made and 11 mammograms were performed. CISD will continue to provide this benefit.

3.4 Food Service Events From 2023-2024

Tina Byrnes stated that the Food Service Department conducted a Farmers Market event at Center Elementary School in April 2024.

3.5 Review of Wellness Policy (FFA)

It is a teledoc office visit and the following tests can be conducted with rapid results; flu, COVID, or strep. If the student is sent home, the system can generate a doctor's note for the campus. Another bonus for this service is if the student requires a prescription, it is called in and waiting for the parent to pick it up before they go home.

FLM will be conducting a Well Child Care Clinic on October 16, 2024. Michelle Davies provided information on the various stations that will be available.
